

Full Feed 9933 Lamb NG

Full Feed 9933 Lamb NG Pellets are formulated to be fed to sheep in a feed lot environment and can also be used while joining, or to maintain growth rates and production in situations where forage quantity and/or quality is limiting.

Lasalocid sodium is included in the pellets to improve feed conversion efficiency and as an aid in the prevention of coccidiosis.



FEEDING RECOMMENDATIONS

Introduce Full Feed Lamb *ad lib.* along with good quality hay for the first 4 to 7 days.

Ensure that sheep have access to palatable hay for a day prior to introduction of pellets.

Monitor sheep during introduction, and if digestive problems occur restrict pellets and increase when digestive activity returns to normal.

Continue to monitor sheep for digestive disturbance for the duration of feed-lotting.

Generally digestive problems will not occur, but if they do it is necessary to act swiftly by introducing roughage until digestive activity returns to normal.

It is important that pellets are available at all times. If pellets run out digestive problems may occur and a reintroduction period may be necessary.

Clean, cool fresh water must be available at all times.

Vegetable oil, molasses, limestone, di-calcium phosphate, salt, urea, bentonite, magnesium sulphate, magnesium oxide, antioxidants and lasalocid sodium.

Vitamins: A, D₃, E.

Minerals: Calcium, phosphorus, sodium, chloride, magnesium, sulphur, cobalt, copper, iodine, iron, manganese, selenium and zinc.
